Levy 2009/10

The summons for the non payers of the e11bid investment for 2009/10 were issued on the 28th July 09. The e11bid levy is a statutory payment that everyone has to pay. The person responsible for the premises on the 8th April 2009 is the liable party.

The BID levy ensures that everyone has to pay towards the investment of the area. Where a property is empty, current NNDR rules provide that such property will be continue to be charged at a percentage of the rateable value. Under e11bid arrangements, there will not be any exemptions for such properties. Charities are not exempt from the BID investment.

Swine Flu Pandemic

Although there have been reports in the press of deaths from swine flu, it's important to emphasise that the vast majority of people will only have a mild illness, and will make a full recovery. Every year, seasonal flu leads to the death of a few otherwise healthy people, but this information does not usually make the news.

Coming to work

Everyone should continue to come to work as usual unless they develop flu symptoms. The virus is now widespread in the community so staying away from work will not ensure that you avoid catching it. If you feel unwell at work or if you have flu-like symptoms while you are at work, please get a replacement manager for your business and go home straight away.

Once you get home you can check your symptoms on NHS Direct www.nhs.uk or call them on 0800 151 3513 (please bear in mind that this line may be very busy). If you are then still concerned, stay at home and call your GP who will decide what to do next. Please do not go to your GP surgery or any other health facility.

If you belong to a high-risk group it is particularly important for you to start taking antivirals as soon as possible and so you should contact your GP straight away. high risk groups include people with long-term conditions, those over 65, children under five and pregnant women.

Please let your staff know straight away if your GP confirms that you have the swine flu virus.

Preventing the virus from spreading

As with any virus, good hygiene will still help to stop other people catching it.

The message remains simple: Catch it. Bin it. Kill it.

Cover your nose and mouth with tissues when you cough and sneeze, throw the tissue away, and wash your hands.

Town Centre Management (TCM)

TCM is a co-ordinated pro-active role designed to ensure that our centres are desirable and attractive places. Traditionally the initiative is a partnership between the public and private sectors and brings together a wide-range of key interests. In recent times BIDS have proved to be the most effective mechanism to implement change within a defined timeframe.

What makes the concept of town and city management so effective is that it also plays a key role in delivering strategic objectives. Detailed Action Plans (e11bidBID 5-Year Plan) identify how the strategy is to be delivered and the partnership acts as the driving force to ensure that delivery takes place. The combination of vision, strategy and action plan, the wideranging partnerships and the effective support and involvement of key interests through working and project groups and individual businesses means that town and city centre management can:



- Create environments that are clean and safe by investing in maintenance and security
- Improve transport, parking, orientation and accessibility
- Add vitality through professional marketing and events programmes
- Stimulate growth by inward investment and development and through work with existing businesses
- Develop branding that stresses distinctiveness and changes perceptions
- Celebrate local heritage through tourism and destination management
- Expand opportunities through developing training and employment programmes
- Increase choice and diversity by promoting and integrating new amenities, residential development and the night-time economy
- Enhance quality through public art and major infrastructure improvements to the public realm
- Ensure that the town or city centre is welcoming to all and an experience worth having

Events

TCM contributed to the Leytonstone Festival and the Leytonstone Arts Trail that temporarily occupied the former Woolworths unit in the town centre. The innovative list of activities designed to stimulate vitality in Leytonstone are contained in the separate A5 leaflet. Our events have been developed so that e11bid businesses can participate to enhance trade. Entertainers and artists from Leytonstone will be showcased and talented students from local schools will have an opportunity to perform.

Town Centre Management (TCM)

Environmental Improvement & Maintenance

Comprehensive improvements are being developed between TCM, LBWF Public Realm and the e11bid Co that include:

- Refurbishment and replacement of street furniture (seats, signage etc)
- Replacement of bent concrete columns and painting of light columns throughout the town centre
- Replacement Guard Railing at Gainsborough Rd/High Rd
- Monitor street cleansing and waste management in the town centre to achieve consistency
- Develop initiatives with enforcement related local authority officers to encourage best practice and avoid local businesses being fined or being subjected to other unnecessary enforcement activity
- Revised drainage channel at Burghley Crescent
- Provision of additional litter bins
- Hanging Flower Baskets
- Public/Private Landscaping and boundary improvements

Strategic Development

TCM comments on, and influences policy decisions that impact on the viability and vitality of the town centre. TCM seeks to proactively protect the town centre by acting as a consultee of the Local Development Framework that will set out future policy direction within a strategic planning framework. A range of variable data relating to retailing, how the area is used, the types of provision that are in demand/decline, available retail floorspace, changes to use class and permitted development will be measured in order to achieve the optimum balance for E11.

We have pushed to ensure that the TCM is a statutory consultee on relevant planning and licensing applications to try and achieve a variety of goods and services whilst minimizing undesirable development. In addition a strategic inward investment strategy is being developed that will encourage investment in the town centre - whether by developers showing an interest or by external commercial operators wanting a local presence.





BlueAd

We are targeting funding that will allow businesses to identify cost saving measures as well as sustainable construction and design packages that will allow us to implement any suggested changes. For anyone interested this funding stream will work on a shared cost basis.

Car Parking CPZ and Increased Congestion

A meeting has taken place to take forward the project to amend the timings of all the Controlled Parking Zones (CPZ) in the BID area. We have seen where other areas use the CPZ scheme effectively to ensure commuters cannot park in the area. For Leytonstone we feel that in this economic decline, any perceived barrier to trade needs to be addressed, and parking certainly counters for one of them. The dual use of residential CPZ for voucher parking will also be highlighted. We are also moving forward with changing of the parking signage for Leytonstone. We have now investigated the use of parking sensors to relay vacant parking spaces numbers and are looking at ways to incorporate this in our town centre. Following the increase in complaints as to the sequencing of the lights, the BID company has good news; TfL have agreed to link the 12 sets of signals around the Town Centre and beyond in a more sophisticated way that will be more reactive to changing traffic conditions. We will publish the programme for installation as soon as we get it.

ShopWatch

As well as the regular luncheon meetings and newsletters we have been in discussion with SafetyNet on a subsidised offer for new applicant members to the ShopWatch radio network. The scheme has also been extended to other parts of the borough as well. In Bakers Arms a mast has been installed to allow for a specific radio channel for businesses in that area. In Highams Park and Leyton Temple Mills, a one on one radio network is being established for dedicated coverage. For Leytonstone the additional back up from our CCTV monitoring stations surveillance will assist in recording transmissions and provide dedicated support. The last security and licensing luncheon was held at Seebos on the 12th August 2009. All radio holders were requested to send representatives to the meeting in order to be up to date with the latest intelligence. For more information contact the BID team on shopwatch@e11bid.co.uk

The Business Incubators

Following on from work to find a suitable funding package for the project, a preplanning application has been made to the LA pertaining to the former conveniences site on Kirkdale Rd. There are 13 offices (1 disabled on ground and 6 each on the other two floors). Meeting room and WC are also on the ground floor. The main planning issues include coming out over the pavement and ownership of the land/air rights. Considerations would also have to made if it would compromise any access/maintenance requirements for services in the pavement in the future. What it does do is provide a landmark and a focal point for the area. Indications are that any decision for the redevelopment of this site would need full planning application.

Trade Waste

Following on from 24 fixed penalty notices being issued to businesses in the e11bid area, plans have been made to introduce collaborative trade waste agreements. This will lead to bins in the shared areas and forecourts of larger businesses and public houses in the area. These trade waste bins will be available for use for all BID businesses as a valid and economic way to dispose of trade waste. Additional to this e11bid is proposing its own trade waste collection which will give cheaper rates to business for collection on shared waste schemes. Any businesses interested in joining our scheme should get in touch.

Branded Leytonstone

Following on from the approval of the "We Are Leytonstone" logo, branded memorabilia is to be circulated at our events. We will move forward with branding existing furniture in BID area including Bins, Benches and Signs.



Exporting Success

The e11bid company has been successful in its part of a joint partnership ERDF application. The contracts are still being drawn up with the LDA but we should soon be creating an e11 Export Club which will identify and help local businesses in their efforts to export. The e11bid company will be a strategic partner with North London Ltd and will form the e11bid Export Club. In return North London Ltd will provide us with funding for the organisation of events, extension of our websites and production of export information.



Procurement and Trucost Event

The WF Business Board has been instrumental in ensuring that the council sets a target for the locally procured at 51%. This will mean tier one contractors for the council will have to increase by 27% in the next two years. This allows for greater opportunities for e11bid members through the e11consortium. The council now forwards any contract opportunities direct to the WF business Board website which in turn is linked to the e11bid.

As part of the perceived barriers to trade, the Council identified Leytonstone and Argall BID businesses as a pilot for free carbon emissions certification. An event to launch this limited time initiative was held in June 09 at the Starlight Lounge in Leyton. We hope to extend this cooperation with the LA to identify local businesses for carbon efficiency audits normally costing £3000.

CCTV

For many of us, the sense of security and comfort for businesses and shoppers is paramount and many of you will sigh with relief when the new CCTV system for Leytonstone is installed. As much as we would like to confirm the final date of operation of the complete system to you all, we are under pressure to ensure the money is well spent and the e11bid board feel its better to have a complete robust mechanism for monitoring rather then recorded surveillance before we implement the installation of the hardware.



The contractor the management board approved for this project is RVTV Ltd. We have been discussing its final implementation including pricing schedules, lamp column replacements and security for our base station and they are confident the system will be one that will exceed the demand we will all place on the network. Along with the 9 primary cameras, we will have a number of other cameras in the area that will record other information such as number plates, facial recognition and footfall gauging software.

We are confident a number of other applications can be utilised on our network that will allow the e11bid company to eventually pay for 24 hour monitoring. The total cost for the project is in the region of £140k and the e11bid company was keen to ensure that a revenue source was identified to ensure the bulk cost of this was not undertaken by e11bid businesses investment but from the service we can provide every business in the BID area from the CCTV coverage.

As such discussions are ongoing to ensure a suitable company can manage and develop the monitoring station to become the primary monitoring station for south of the borough. The e11bid has applied for the council contract to deliver CCTV monitoring in this region rather then the existing monitoring of cameras contracted to Enfield. We feel our base station will be best placed to coordinate and manage the CCTV especially in the light of urgent responses often demanded by members of our ShopWatch Radio.

Interviews took place in July and we have employed Shamimul Islam as the new e11bid company apprentice. He has started already and will be making his rounds to visit each and everyone of you.
